## GCSC Board Minutes April 5, 2021

Attending: Kim Bryson, Robin Gerber, Steve Blain, Stephanie O'Neill, Annan Ponnambalam, Leslie Schreiber, Jon Lambert

Called to order at 4:40 pm

Minutes of March 1, 2021 board meeting of were adopted as amended.

### President

- Road striping- bid received for \$2970 (7 ft. dashes spaced 14 feet apart, three road width stripes)
  - additional bid will be sought
- Graffiti on wall at south end of Arundale is gone. Nancy Geberech had it done

### Treasurer

- \$105,466 in bank accounts
- - \$630 remain in accounts receivable for first quarter 2021
- All account payments are now due within 30 days of receiving invoice. Based on previous GCSC resolution. Statement to that effect show on the invoice.
- The Statement of Information form for the GCSC is due. Leslie will complete and submit it.
- Jon informed the group that he is the custodian of funds from Tootie Hogenboom, a former resident of Taormina. She left funds to care for the Gazebo but, since the GCSC does not have permission to use the Gazebo, the funds will be donated to the GCSC.

### Old Business

#### Garbage/recycling area

- The Trash Committee has met and is working on creating a new sign to replace the several currently hanging in the trash area (Linda Lambert, Bruna O'Neill). They will be asked to address the matter quickly.
- There is to be no posing of signs by community members on the trash area gate. It was proposed that the community bulletin board be moved to one side of the trash area gate and the new GCSC sign to hang on the other side.

#### Roads

- The City is moving very slowly. There is a budget problem so addressing the Taormina Lane & Arundale Road takeover is postponed.

#### Krotona water system

- Casitas Water has been surveying the Taormina roadways. Guru Presad (Krotona head) has told us he will submit plans to the GCSC once they are available.
- - Jon will contact him seeking a timeline and notify him of the GCSC's plans for road painting at the Arundale-Taormina Lane junction.
- Landfield car is back and parked on the road; it is unregistered. Kim will notify Daniel Landfield about the GCSC regulations of citing and then towing such automobiles.

- House #16 is showing ore materials collecting in the yard. Leslie will attempt to talk with Terrell Ann and with Sherry Petyrofsky (her relative that owns #115 where Terrell is currently living). A general discussion of Taormina property ownership ensued.
- Kim will continue to draft a letter to the Taormina community about what the GCSC has been and is doing.

#### New Business

- Thank you to Anan for meeting with the Nordhoff HS principal and resolving the issue of the closed gate between Taormina and the school. The principal was primarily concerned of the expanding use of the HS playing fields as a dog park.

Announcements- next meeting is scheduled for May 3<sup>rd</sup> 2021 at 4:30 pm – to be a Zoom meeting.
